CONSTITUTION of the DANIELL BAPTIST ASSOCIATION

ARTICLE I. NAME

The name of this organization shall be the Daniell Baptist Association, Incorporated, (also known as "DBA," hereafter referred to as the Association).

ARTICLE II. PREAMBLE

These Bylaws shall serve to preserve the principles of our faith, guarantee the liberties of each individual church, and serve as a guide for action in keeping with the historic purpose of this association of Southern Baptist churches.

ARTICLE III. PURPOSE

The Daniell Baptist Association exists to bring glory to God through facilitating partnerships between churches to accomplish the Great Commission.

ARTICLE IV. ARTICLES OF FAITH

The Bible is the sole authority for determining doctrine. The Baptist Faith and Message adopted by the Southern Baptist Convention on June 14, 2000 is accepted as an expression of our beliefs.

ARTICLE V. MEMBERSHIP

A. Definition:

This Association is a voluntary fellowship of local Southern Baptist churches that agree in general with The Baptist Faith and Message (2000) and cooperate in fulfilling their mission.

B. Qualifications:

Member churches of the Association shall exhibit the following:

- 1. Each church shall be a duly constituted, autonomous body, which is scriptural in belief and practice.
- 2. Each church shall have doctrines and practices that agree with the Bible and in general with The Baptist Faith and Message (2000).
- 3. Each church shall exhibit a cooperative missionary spirit and practice.
- 4. Each church shall actively and financially participate in the work of the Association.

C. Responsibilities:

Member churches of the Association are urged to take seriously their responsibilities to support the cooperative work of the Association. Member responsibilities include:

- 1. <u>Reporting:</u> Each church shall inform the Association of its annual progress by submitting the Annual Church Profile when requested by the Association.
- <u>Financial Support</u>: Each church is encouraged to contribute financially to the work of the Association. It is requested that each member church include the Association in its budget on a percentage basis and give at least 3% of its undesignated receipts to the Association.
- 3. <u>Fellowship and Representation:</u> Each church is encouraged to send its full number of messengers and Executive Committee representatives to the meetings of the Association.
- 4. <u>Convention Support:</u> Each church is encouraged to contribute to Southern Baptist Convention mission causes through the Cooperative Program.

D. Representation:

- 1. Each member church shall elect messengers to the Annual Meeting of the Association.
- 2. Each church with two hundred (200) members or less shall be entitled to five (5) messengers. Each church shall be entitled to an additional messenger for every fifty (50) members, or a fraction thereof, in excess of two hundred (200) members, not to exceed a total of fifteen (15) messengers.
- 3. The pastor or his appointed representative and one lay person of each church shall serve on the Executive Committee of the Association. If the church is without a pastor, the church may elect someone else to serve until a pastor is called.

E. Reception of Churches

- 1. A church desiring to become a cooperating member of the Association will petition the Association in writing and provide such documentation as required by the Association. The petition will be assigned to a Credentials Committee established by the Executive Committee to examine such petitions. After review, the Credentials Committee will make its recommendation to the Administrative Ministry Team as to the qualifications of the petitioning church.
- 2. Upon approval of the Administrative Ministry Team, the petitioning church shall be assigned watch care status for six (6) months and will be provided all the services of the Association with the exception of the right to send voting messengers to the Association. If the petitioning church is the result of a split, a twenty-four (24) month watch care status will be assigned in the hope that, after prayer and the passing of time, forgiveness and healing will take place between the two churches. However, the petitioning church may request of the Administrative Ministry Team that the extended 24-month guideline be waived for due cause.
- 3. During the watch care period, the Credentials Committee will examine all information provided and will monitor the activities of the petitioning church to establish satisfactory evidence that it continues to meet the qualifications set forth in Article V, paragraph B.
- 4. Upon completion of the six-month watch care period, if the petitioning church has established satisfactory evidence set forth in Article V, Section B, a special meeting of the Executive Team will be called, pursuant to Article VII, Section B. The Credentials team will make a recommendation for membership of the petitioning church into the Association of members present is required to receive the petitioning church into full membership status.

ARTICLE VI. AUTHORITY

The Association shall have no power to control or interfere with the sovereignty of the individual churches. It shall have power by a majority vote of the messengers present and voting at the annual business meeting to terminate the membership of any church that no longer meets the qualifications for membership.

ARTICLE VII. MEETINGS

A. <u>Regular Meeting</u>: The Association shall hold one annual business meeting that shall be considered the Annual Corporate Business Meeting. The format, time and place of this and any other meeting will be determined by the Executive Committee upon recommendation from the appropriate committee established for such purpose.

B. <u>Special Meetings:</u> Additional meetings of the Association may be called by the Executive Committee at any time. The Executive Committee shall be required to call a special meeting upon petition in writing of ten (10) member churches in good standing; and such petition shall state the purpose of such specially called meeting.

C. <u>Notice:</u> Notice of each regular or special meeting shall be given in writing to each member church at least thirty (30) days prior to such meeting. Such notice may be given electronically or by such other means as determined by the Executive Committee.

D. <u>Voting:</u> Each messenger shall be entitled to cast one vote. All questions shall be decided by a majority vote of those members present and voting unless otherwise provided by the Articles of Incorporation, these Bylaws or by law. No proxy or absentee voting shall be allowed.

E. <u>Quorum:</u> At any regular or special meeting of the Association, those messengers in attendance shall constitute a quorum if due notice has been given as provided herein above. Attendance at any meeting shall constitute a waiver of any required notice unless such attendance is solely for the purpose of objecting to the sufficiency of such notice.

ARTICLE VIII. OFFICERS

A. Designated Officers:

The officers of the Association shall be Moderator, Vice Moderator, Clerk, Assistant Clerk, Treasurer, Assistant Treasurer, Historian, Parliamentarian, Assistant Parliamentarian and Associational Mission Strategist.

B. Provisions applicable to Officers Generally

- 1. General Application: The following paragraphs shall apply to all officers except the Associational Mission Strategist.
- 2. Nomination, election and installation: The officers shall be nominated annually by the Administrative Team and elected by the messengers at the Annual Business Meeting. The officers shall be installed at the Annual Business Meeting and commence service immediately upon the close of the meeting.
- 3. General qualifications: Each officer shall be (1) a person of spiritual maturity and commitment, (2) willing to cooperate in the work of the Association and the denomination as a whole and (3) a member of an Associational member church that financially supports the Association.
- 4. Term of Office: All officers shall serve a term of one year.
- 5. Vacancy: A vacancy in any office may be filled by the Executive Committee for the unexpired portion of the term, provided the person so appointed shall first be nominated by the Administrative Team.
- 6. Removal: Any officer may be removed for cause by the Executive Committee whenever in its judgment the best interest of the Association will be served thereby.

C. Moderator

- 1. Qualifications: The Moderator shall be familiar with the programs and services of the Association and have a working knowledge of parliamentary procedure.
- 2. Responsibilities: The Moderator shall: (a) preside over meetings of the Association and Executive Committee; (b) assist the Associational Mission Strategist in preparing the agenda for Executive Committee meetings; and (c) be an ex-officio member of all Association committees and teams.
- 3. Successive Terms Limited: A person may be elected to the office of Moderator for no more than two consecutive terms. After the expiration of his second full term as Moderator, a person shall not be eligible for election to that office again until at least one full year has elapsed. Time of service in filling a vacancy in the office of Moderator shall not disqualify a person from thereafter serving two additional terms.

D. Vice Moderator

- 1. Qualifications: The qualifications of the Vice Moderator shall be the same as those for Moderator.
- 2. Responsibilities: The Vice Moderator shall: (a) perform the duties of Moderator when the Moderator is absent or unable to act; (b) be responsible for the introduction of the new pastors and staff members to the Association at a meeting of the Executive Committee; and (c) be an ex-officio member of all committees and teams.
- 3. Successive Terms Limited: A person may be elected to the office of Vice Moderator for no more than two consecutive terms. After the expiration of his second full term as Vice Moderator, a person shall not be eligible for election to that office again until at least one full year has elapsed. Time of service in filling a vacancy in the office of Vice Moderator shall not disqualify a person from thereafter serving two additional terms.

E. Clerk

- 1. Qualifications: The Clerk shall have an aptitude for keeping and preserving records.
- 2. Responsibilities: The Clerk shall: (a) serve as recorder at all regular and special meetings of the Association and the Executive Committee; (b) keep a register of participating churches, showing the dates of organization and admission to the Association; and (c) perform such other duties as shall be assigned by the Executive Committee.

F. Assistant Clerk

- 1. Qualifications: The qualifications of the Assistant Clerk shall be the same as those for the Clerk.
- 2. Responsibilities: The Assistant Clerk shall perform the duties of Clerk when the Clerk is absent or unable to act.

G. Treasurer

- 1. Qualifications: The Treasurer shall possess competence in basic accounting procedures.
- 2. Responsibilities: The Treasurer shall:
 - a. serve as an ex-officio member of the Association's Finance Committee;
 - b. work with the Finance Committee to recommend and establish fiscal policies;
 - c. oversee the maintenance of adequate records of all monies received and disbursed;
 - d. oversee the posting of records of the contributions of each participating church and report them at least quarterly;
 - e. examine supporting data for all check requests and sign checks as required by the Executive Committee; and
 - f. make reports to the Finance Committee, Associational Mission Strategist, Executive Committee and at the Annual Business Meeting.

H. Assistant Treasurer

- 1. Qualifications: The qualifications of the Assistant Treasurer shall be the same as those for the Treasurer.
- 2. Responsibilities: The Assistant Treasurer shall perform the duties of Treasurer when the Treasurer is absent or unable to act.

I. Historian

- 1. Qualifications: The Historian shall demonstrate ability in the concise recording of historical material.
- 2. Responsibilities: The Historian shall:
 - a. gather and preserve historically significant Associational records of the past;
 - b. assist in recording of present day activities;
 - c. develop and recommend to the Association policies and procedures regarding its historical materials; and
 - d. report historical information as requested by the Executive Committee.

J. Parliamentarian

- 1. Qualifications: The Parliamentarian shall:
 - a. be well versed in parliamentary procedures according to the latest edition of Robert's Rules of Order; and
 - b. have a working knowledge of the Association's Bylaws.
- 2. Responsibilities: The Parliamentarian shall:
 - a. be the recognized authority on matters pertaining to parliamentary procedures in the business meetings of the Association and the Executive Committee;
 - b. interpret the rules for the moderating official when requested; and
 - c. perform the duties of Moderator when both the Moderator and Vice Moderator are absent or unable to act.

K. Assistant Parliamentarian

- 1. Qualifications: The qualifications of the Assistant Parliamentarian shall be the same as those for the Parliamentarian.
- 2. 2. Responsibilities: The Assistant Parliamentarian shall perform the duties of Parliamentarian when the Parliamentarian is absent or unable to act.
- L. Associational Mission Strategist
 - 1. Qualifications: The qualifications of the Associational Mission Strategist shall be determined by the Executive Committee.
 - 2. Selection and Employment:
 - a. Whenever a vacancy occurs in the office of Associational Mission Strategist, the Executive Committee shall appoint a search committee that shall recommend a suitable candidate for the office to be approved by the Executive Committee.
 - b. The terms and conditions of employment shall be such as are mutually agreeable to the Executive Committee and the prospective Associational Mission Strategist.
 - 3. Employment at Will: The Associational Mission Strategist shall serve at the pleasure of the Executive Committee and the Association. The Executive Committee or the Association, in a regular meeting or a special meeting called for such purpose, may declare the office of Associational Mission Strategist vacant whenever the Committee or the Association in such meeting determines it to be in the best interest of the Association.
 - 4. Responsibilities: The Associational Mission Strategist shall:
 - a. lead in planning, promoting and executing the work of the Association;
 - b. exercise direct supervision over other staff members;
 - c. be the principal executive officer of the Association;
 - d. sign all legal documents on behalf of the Association, unless the signing of particular documents shall be expressly delegated by the Executive Committee, these Bylaws or by law to some other officer or agent of the Association; and
 - e. perform such other duties as shall be assigned to him by the Executive Committee from time to time.

M. Other Officers and Staff: The Association shall have such other or additional officers or staff as the Executive Committee may deem necessary for the effective operation of the work of the Association.

ARTICLE IX. THE EXECUTIVE COMMITTEE

A. Membership: The membership of the Executive Committee shall be as follows:

- 1. the officers of the Association; and
- 2. the pastor of each member church or his representative and one additional lay member elected by each member church (In the absence of a pastor, the church may elect an alternate member to represent the church.).

B. Meetings:

The Executive Committee shall have 1 regular meeting during the year at such time and place as the Executive Committee shall determine. The Moderator may call special meetings of the Executive Committee when he deems necessary.

- C. Powers and Duties:
 - 1. The Executive Committee shall be the statutory Board of Directors of the Corporation however, day to day operation shall fall under the supervision/authority of the Administrative Ministry Team The number of directors shall be equal to the number of members of the Executive Committee as fixed in Section A of this Article.
 - 2. The Executive Committee shall be authorized to secure an Associational Mission Strategist to be employed by the Association to promote the Association's programs and services, subject to the provisions of Section VIII, paragraph L of these Bylaws.
 - 3. The Executive Committee will receive reports from committees to be presented to the annual business meeting of the Association for approval by the body.
 - 4. The Executive Committee shall present an annual report of its activities to the annual business meeting of the Association.
 - 5. The Executive Committee may appoint additional committees and teams as provided in Section X of these Bylaws.

ARTICLE X. OTHER COMMITTEES AND TEAMS

The Association shall have such additional committees and teams as the Executive Committee deems appropriate. The composition, term, duties and procedures of each committee shall be set forth in one or more policies to be adopted by the Executive Committee.

ARTICLE XI. AMENDMENTS

These Bylaws may be amended by a two-thirds majority vote of the members present and voting at the Annual Business Meeting of the Association or at any special meeting of the Association called for such purpose. The text of the proposed amendment shall first be presented in writing to the Executive Committee for review. The Executive Committee shall review the proposed amendment and provide counsel on its wording. No bylaw amendment shall be presented to the Annual Business Meeting of the Association without the recommendation of the Executive Committee. The text of the proposed amendment shall be included in the notice of any meeting at which the amendment is to be considered.

ARTICLE XII. GENERAL ITEMS

- A. This Association shall be bound by the current edition of Robert's Rules of Order, as amended from time to time.
- B. In addition to these Bylaws, the Association may have such additional rules, policies, and procedures for the conduct of its business and activities as shall be deemed necessary by the Executive Committee. The Executive Committee shall be authorized to adopt, amend or revoke such rules, policies and procedures.

MINISTRY PROCEDURES MANUAL of the DANIELL BAPTIST ASSOCIATION

WHAT ARE MINISTRY TEAMS?

Ministry Teams are composed of members of Daniell Baptist Association churches who are ministry sensitive believers, gifted leaders who lead in the fulfillment of the mission and objectives of the Association by using the most effective strategies available. Some of the most exciting Ministry Teams are already functioning, staffed by experienced volunteers and professionals in their field, who give of their time and resources to serve. Any DBA church member in good standing is welcome to seek consideration for membership on any Ministry Team for which they feel called and qualified to serve.

MINISTRY TEAMS PROCEDURAL GUIDELINES

- 1. Participation in Ministry Teams should involve people from as many member churches (and different regions) as possible.
 - a. Members of DBA churches in good standing may participate prior to formal approval by the Executive Committee when invited by a Team Leader and approved by the Associational Mission Strategist. Interested volunteers may contact a Team leader, Team, or the Associational Mission Strategist for consideration and an invitation to join.
 - b. Teams should feel free to involve others outside their Team to help them with their ministry as needed.
 - c. Team Leaders and members serve on a three-year rotation system but may serve consecutive terms.
 - d. Team members may be affirmed or denied Team participation at any meeting of the Executive Committee.
- 2. The Administrative Team in consultation with, and approval of the Associational Mission Strategist, will choose Team Leaders for each Ministry Team. All Team Leaders will automatically serve on the DBA Administrative Team.
- 3. Each Ministry Team is to identify and develop resources for its ministry. Direct solicitation of funds from DBA churches for a particular ministry is prohibited unless approved by the Finance Ministry Team. Budget items being requested for inclusion in the DBA annual budget must be presented to the Associational Mission Strategist in time for presentation to the Finance Committee. This does not prohibit responding appropriately to natural disasters through the DBA office.

ACTS 1:8 MISSIONS TEAM

Composition: Shall be composed of at least 6 members. Responsibilities:

- 1. Plan, promote, conduct and evaluate Associational mission activities in accordance with Acts 1:8.
- 2. Lead the Association in being an Acts 1:8 Association.
- 3. Be proactive in starting new churches, ministering in times of disaster, and provide training in the Acts 1:8 strategy.

ADMINISTRATIVE MINISTRY TEAM

Composition: Shall be composed of the officers of the Association as well as the TeamLeader of each Team. The Moderator will serve as Team Leader of the Administrative Ministry Team. Responsibilities:

- 1. Assist the Association in coordinating its work and mission by strategically organizing resources and the yearly calendar.
- 2. Work together with the Associational Mission Strategist. to present a yearly calendar which will facilitate fulfilling the mission of the Association.
- 3. Serve as a sounding board and resource for the Associational Mission Strategist.
- 4. Allocate money from the Acts 1:8 fund for mission purposes and report all expenditures to the Executive Committee.
- 5. Provide new ideas to help the Association fulfill its mission.
- 6. Handle all personnel matters as needed.
- 7. In consultation with the Associational Missionary Associational Mission Strategist., elect, interview and enlist general officers, Team members, Team Leaders and any other elected positions required by the Bylaws.
- 8. Assist Associational leaders to discover and enlist qualified persons to fill positions in their respective ministries.
- 9. Nominate special teams as assigned by the Executive Committee.

ANNUAL SESSIONS MINISTRY TEAM

Composition: Shall be composed of the Moderator, Vice Moderator, and Associational Mission Strategist.

Responsibilities:

1. Select the date, time and place for the next year's Annual Meeting and submit those recommendations for approval at the Annual fall meeting of the Executive Committee.

CHILDREN'S CAMP MINISTRY TEAM

Composition: Shall be composed of at least three members. The Team Leader will serve as Camp Director.

Responsibilities:

- 1. Plan and implement the Summer Camp.
- 2. Responsible for recruiting and selecting workers for the Summer Campmaking sure each worker is screened through the Associations Child ProtectionPolicy.
- 3. Plan and implement a publicity strategy which targets the community and all churches in the area.

COLLEGIATE MINISTRY TEAM

Composition:

1. Shall be composed of at least three members.

2. The Baptist Campus Ministers in our DBA area.

Responsibilities:

- 1. Work closely with the Baptist Campus Ministers in developing a comprehensive ministry to the college campuses.
- 2. Introduce Jesus Christ to college students on and off campus
- 3. Involve college students in evangelistic missions beyond the campus
- 4. Help college students become fully devoted followers of Christ
- 5. Help students get involved in a local church
- 6. Help the Campus Ministry relate to the local churches.

CREDENTIALS MINISTRY TEAM

Composition: Shall be composed of at least 3 members. Responsibilities:

- 5. Oversee the Watchcare process after the church has been initially presented to the Executive Committee.
- 6. Seek to restore fellowship with churches that have become delinquent in their support of the Association, and, if efforts fail, make appropriate recommendations to the Association.
- 7. Oversee credentials of those voting at the Annual Meeting.

EVANGELISM MINISTRY TEAM

Composition: Shall be composed of at least 3 members. Responsibilities:

- 1. To partner with churches to reach their communities for Christ.
- 2. Promote cooperative efforts in mass evangelism.
- 3. Challenge and equip churches to be inwardly strong, outwardly focused.
- 4. Network with other Great Commission Organizations to assist churches to be personally involved in evangelistic missions.

- 6. Plan and implement evangelistic opportunities.

FINANCE MINISTRY TEAM - CHANGED TO REFLECT INTERNAL FINANCIAL CONTROLS Composition:

- 1. Shall be composed of six FOUR members.
- 2. The treasurer shall be an ex-officio member by virtue of the office.

Responsibilities:

Minutes of the DANIELL BAPTIST ASSOCIATION Called Executive Team Meeting Daniell Baptist Association Office March 4, 2021

On March 4, 2021 the Executive Team met for a special called meeting to consider a recommendation from the Finance and Administrative Team.

Recommendation: The goal is to keep three months of operating funds in the General Fund Account and keep three months in the Reserve Fund. At the end of 2020, the DBA had

General Fund Cash	\$ 55,548.46
Associational Reserve Fund Balance	\$ 41,529.11
Subtracting the General Fund amount of	\$ 55,548.46
From the estimated three month operating budget	<u>\$ 33,000.00</u>
Gives an overage of	\$ 22,548.46

The excess in the Reserve Fund is to grow so that in five years the DBA can generate mission money. The excess in the general fund can be used for immediate opportunities or necessities.

The Finance Team anticipates a potential for excess again in 2021 given the travel restrictions internationally and potential summer camp closures again.

The Finance and Administrative Teams recommend this money be used to purchase a quality used 15 passenger van for the use of the DBA churches and for any remaining money to be used to bless a mission or ministry that is engaged in accomplishing the Great Commission. Further, the Finance Team recommends that the current DBA 15 passenger van be donated for ministry use to the Sweet Onion Christian Learning Center.

After some discussion, Moderator Kerry Walker noted that this recommendation comes from the Finance Team & Administrative Team in the form of a motion, therefore no second is needed. The Executive Team unanimously voted to approve the recommendation as presented.

Bro. Kerry read from Psalm 126.

A discussion ensued concerning a work partnership with the Dream Center. It was decided that the DBA would encourage pastors & churches to participate in missions through construction when the opportunities became available.

Team Reports

Credentials Team: Dannie Williams informed the team that Better Together Ministries will have completed their 6 month watchcare period on January 23, 2020. A proposed date for February 18th, 2020 was given for a special Called Executive Team meeting to vote on full DBA church membership for Better Together Ministries.

Ministers Wives: Kellie Bellflower relayed that the Ministers Wives met together in 2019 and had a good fellowship at Gwen Williams' barn. The team is considering a Saturday morning coffee fellowship in February. The date will be announced.

Surge Camp: Laura Hay informed the team that Winter Surge would take place February 21-22, the theme is Go and will focus on missions. The Cokers of FBC Alamo will be one of the speakers and will share their experience in Russia Missions. Peggy NeeSmith of the Dream Center will also come and share her testimony. The group will perform mission projects around the community.

Collegiate Team: Billy Puckett informed the team that Madison Herrin is no longer the Baptist Campus Minister at Brewton Parker College. Steve Edwards will be taking on this roll for the time being.

Evangelism Team: Billy Puckett noted that we currently have between 25-26 churches that have committed to pray for the people on their prayer list for the Prayer for Every Home Bible in Every Home campaign. Three churches have sent in the \$500 support. There has been some interesting developments as the churches pray for every person on their lists.

One church member received a name of a woman that had an affair with his/her father, but committed to pray for them anyway.

One church member had a particular Holy Spirit pull to one name on his/her list, but did not know the person. It was later connected through a customer of the church member that the person being prayed for had lost a child.

The Evangelism Team will hold a conference on February 28, 2020 for A Prayer for Every Home A Bible in Every Home, with a focus on evangelism and apologetics, called Proclaim.

Yard signs, billboards, and social media pushes for a Bible in Every Home will begin in March.

Missions Team Report: Billy Puckett explained that there have been a few trips to the Green Turtle Cay, Bahamas, who is currently in partnership with the GBMB. Tabernacle is the lead church, making connections with the church in the Bahamas to ascertain if a Baptist church can be planted there. There are very few churches in Green Turtle Cay, none of which are Baptist, however there is a great sense of community. We are working to bring out the Spiritual aspect and incorporate it with the sense of community that already exists. The next trip to Green Turtle Cay is over Spring Break, and another possible trip may happen in May.

Dannie Williams shared that the next trip to India will be in March 2020, coupled with a trip to Turkey. The time spent in Turkey will consist of visiting the seven sites of the seven churches and sharing the Gospel at each of these sites. In India the pastors will disciple the new pastors of India for three days and participate in evangelism. Funds for Bibles and tracts are currently needed for India.

Billy shared that the Women's Mission Trip to New Orleans was impactful as the ladies shared the Gospel many and served in various capacities. The women are considering a return trip to New Orleans and Mexico at the moment.

A mission trip is currently planned to Mexico this summer.

Billy relayed that the Prison Ministry is as good as it has ever been. Currently, the ministry has teachers serving on Wednesday mornings, Sunday mornings, and Sunday evenings. Dannie Williams shared that the Montgomery Prison is looking for someone to preach.

Acts 1:8 Fund: Kerry Walker reviewed those who received support from the Acts 1:8 fund and asked the team how they would like to proceed. After some discussion, Dannie Williams motioned to reduce Mercy Medical, Dream Center, and Rachel's House to \$1000 annual, remove Iglesia Bautista Vida Nueva, leave Sweet Onion Christian Learning Center as is at \$1800 annually, add \$1000 to go to India and add \$600 to go to a North American church plant. Laura Hay seconded, all approved.

Sweet Onion Christian Learning Center request: The Sweet Onion Christian Learning Center submitted a request for the use of the DBA to transport students in Lyons and Vidalia to and from class. After some discussion the motion was made that the team deny this request based on the age and current maintenance status of the van, the motion was seconded, all approved.

Evangelism

Bro. Billy reminded everyone that an updated list of household names, addresses, and other good information has been sent to the pastors via email. The Evangelism Team hopes that the pastors will use this list for prayer and to invite people to church as a part of the Prayer for Every Home, Bible in Every Home campaign.

Finance

Bro Luis reviewed the financial statement with the team. He noted that the Finance & Administrative Team made a recommendation to the Executive Team to use the excess funds from 2020 (\$22,548.46) to purchase a reliable used van, repair the current van and give it to the Sweet Onion Christian Learning Center, and any funds left after this

would go to an Acts 1:8 recipient. Therefore, there is an expenditure of \$18,857.90 in line item B106, Van Purchase & Transfer.

This cost affects the total expenditures for the month, which reads \$28,771.25. Normal business practice, however, was \$9,913.35 (28,771.25-18,857.90).

The Total YTD reads \$46,360.13, but the actual normal business expenditures were \$27,502.23 (46,360-13-18,857.90).

Additionally, the YTD Net reads -17,699.93; however, actual normal business expenditures should be figured: Income: 28,660.20

Expenses 27,502.23 (Normal Business Expenditures)

YTD Net 1,157.97

Therefore, the DBA has a current profit of \$1,157.97.

It is likely that there will be an excess of funds again for 2021.

Minister's Wives

Bro. Billy relayed that he spoke with Sis. Kellie Bellflower who is in the process of planning a possible event for the minister's wives soon.

Missions

Bro. Billy shared that he spoke with Bro. Joey Davis about missions in Mexico. Due to current travel restrictions in Mexico, there is not a mission trip planned at this time.

He also spoke with Bro. Drew Bolin about the Bahamas mission trip. It will take place July 19-26. Harmony Baptist Church and Tabernacle Baptist Church will be participating. Bro. Kerry shared that the team will be working on constructing the church building on the trip.

Bro. Billy shared that he has a meeting with REAL Discipleship Women's Ministry and they are interested in a mission trip back to New Orleans, LA.

Bro. Dannie shared that conversions continue to grow in India. Pastor Pandu Madalla recently held a crusade that Bro. Dannie was able to remotely attend via Zoom. This crusade produced 36,000 decisions for Christ among the Muslim attendees. Each of these converts needs a Bible. Pastor Pandu also has over 500 village pastors that need training in how to study the Bible and basic discipleship.

Mexico

Bahamas

The team was able to raise half the money for the trip. The churches of the DBA have experienced many difficulties this past year. Several of our churches remain without a pastor and some lost their pastor. INTERNAL FINANCIAL CONTROLS

The internal financial controls of the Daniell Baptist Association serve as a basis for all financial and accounting procedures. In the event that those procedures allow gaps in accounting practices, we will employ accounting practices that conform to Generally Accepted Accounting Principles (GAAP).

Any financial accounts of church plants kept by the Daniell Baptist Association will adhere to that church's internal financial controls.

Operations Matrix

- The Executive Committee of the Daniell Baptist Association (DBA) serves as the Board of Directors to the DBA. The Executive Committee approves the budget of the DBA and carries out additional duties as described in this manual.
- The Treasurer acts as the Chief Financial Officer of the Daniell Baptist Association and serves as an ex-officio member of the Association's Finance Committee.

The Treasurer is responsible for

- general financial oversight.
- recommends and establishes fiscal policies.
- oversees the maintenance of adequate records of all monies received and disbursed.
- examines supporting data for outgoing fund requests, signs checks/expenditures as required by the Executive Committee, approves payments.
- advises the various committees, teams, and staff members in financial procedures, and budgeting.
- reviews monthly financial reports.
- reports the financial standing of the DBA to the Association Mission Strategist (monthly), the Executive Committee (annually), and other relevant committees/teams at appropriate time intervals.
- any other duties within this manual.

- The Finance Committee is composed of at least four members, in addition to Treasurer. The Finance Team
 - prepares and submits a proposed budget to the Administrative Committee and then the Executive Committee for the next Associational financial year. Changes approved by the Executive Committee shall be incorporated into the proposed budget.
 - conducts studies and makes recommendations to the Executive Committee or the Association concerning proposed expenditures not included in the budget.
 - reviews expenditures quarterly in terms of budget allocations and income, recommending budget adjustments as needed.
 - any other duties within this manual.
- Association Mission Strategist (AMS) is charged with overseeing that the funds of the Daniell Baptist Association are used in accordance with the approved budget and in such a manner as to strive toward the mission of the DBA: *Churches partnering together to accomplish the Great Commission*. The AMS is an ex-officio member of every DBA Team and helps the teams to be good stewards of their allotted budget and assists in creating the Team's proposed budget each year. Any other duties within this manual.
- Executive Administrator (EA) conducts the day-to-day financial operations
 - receives donations/payments,
 - makes deposits, writes checks, pays bills (via check, online, over the phone),
 - signs checks, as needed with or without approval (digital is acceptable, see page 10)
 - runs payroll,
 - pays federal and state payroll taxes,
 - reconciles accounts against bank statements,
 - prepares financial statements and submits the statements to the Treasurer (monthly), Association Mission Strategist (monthly), Executive Team (annually), any other committees/teams at appropriate time intervals, and to the churches of the DBA (upon request),
 - maintains the financial records at the Daniell Baptist Association Office,
 - any other duties within this manual.
- DBA Teams may or may not have a budgeted amount to spend each year. The Team Leader is responsible for working with the AMS to request an annual budget, and oversee that any expenditures from the team's budget is used for the team's purpose in the mission of the DBA. Any other duties within this manual.

<u>General Guidelines</u>

Budgeting

The AMS will work with Team Leaders to obtain budget requests each year. Budget requests must be submitted by the Finance Committee to the Administrative Team by the July/August Administrative Team Meeting every year for review. The Administrative Team will review, make any necessary changes or approve, and make a recommendation to the Executive Board to approve the budget. Budget approval takes place at the Annual Business Meeting.

Expenses Exceeding Approved Budget Amounts

An annual budget is to be approved by the Executive Committee of the Daniell Baptist Association. The approved line item amounts are not to be exceeded *except* under the following circumstances:

- Regularly billed items such as utilities, financial fees, insurances, subscriptions, etc. may be paid; however, the Treasurer must be notified as soon as expenses are anticipated to exceed the approved budget amount.
- If expenses for the year, especially near the end of the budget year, appear to pose the potential to exceed the approved budget, the Treasurer may approve up to a 5% increase of the budgeted line item limit. However, this presupposes the financial stability of the organization prior to the request.
- If expenses for the year, especially near the end of the budget year or in times of extreme ministry need, pose the potential to exceed the approved budget, and the need is great than the 5%, which can be approved by the Treasurer, then the Treasurer and Finance Committee may request approval from the Administrative Committee up to a 10% increase in the line item budgeted amount.
- Any increase in a budgeted line item beyond 10% must be brought before the Executive Committee by phone, email, or meeting and approved by two-thirds consent of those available.
- Payroll increases are excluded from increases as listed above without a newly approved budget approved by the DBA in accordance to bylaws or other governing documents.

Excess of Funds

The DBA should strive to have enough cash on hand to cover at least three months of estimated operating expenses. If there is an excess of funds, the AMS and Treasurer may work together to make recommendations on how to best steward the excess funds. The spending of these funds must be recommended by the AMS, Treasurer, Finance Team, and Administrative Team. The Executive Team must approve the expenditure.

The Handling of Cash

In situations involving the collection or dispersion of cash in small amounts, follow the following general guidelines;

- Whenever possible, have two people handling cash. They should both be involved throughout the process, including the counting process.
- Cash should be deposited at the first possible opportunity. A copy of the deposit slip should be filed away as documentation for the deposit. In the event that cash cannot be deposited until later, the deposit must be secured under lock and key, preferably in a location not well known to others.
- For events, a log of total cash received should be recorded, signed by two people, and attached to the bank statement.
- All cash receipts should be recorded in QuickBooks and marked as cash.

As the Executive Administrator and AMS possess credit cards, petty cash should not be maintained on site.

No personal funds are to be co-mingled at any time with ministry funds.

Special Circumstances Involving Cash

- At times a team leader may receive cash funds for an event, and may use those cash funds for ministry purposes. Receipts for cash spending must be turned into the EA. If the full amount is not of cash is not spent, it must be turned into the EA.
- Mission trips usually require cash for expenses while on mission.
 - A Mission Trip Cash Request form should be filled out for cash for mission trips, with the amount and purpose clearly stated.
 - The Mission Trip Cash Request Form should be approved by the Mission Team Leader, AMS, and Treasurer. In the event that all three cannot approve, at least two must approve the Mission Trip Cash Request Form.
 - Upon approval of the Mission Trip Cash Request Form check can be made out to 'Cash' and cashed by the Executive Administrator, AMS, Mission Team Leader, or Treasurer. The funds will then be given to the person who will be handling the cash on the mission trip.
 - The recipient of the cash will sign the Mission Trip Cash Request acknowledging receipt of funds, and the EA, AMS, or Treasurer will witness the receipt.
 - The recipient of the cash will maintain receipts of all funds spent while on mission. A receipt book will be given to the recipient for recording any handwritten expenditures.
 - Receipts, receipt book, and any funds not spent must be returned to the Executive Administrator within five (5) days of returning from the mission trip
 - Cash returned will be recorded in Quickbooks and redeposited into the proper account.

Reporting Procedures

Bank statements

- Should be received via the bank's website, should be printed, used to reconcile accounts, stamped to show completion, and a copy of the Reconciliation Report attached to it once the reconciliation is completed.
- A copy of each account's bank statement and reconciliation report should be given to the Treasurer monthly, (digital is acceptable).
- The hard copy should be filed with the Reconciliation Report.
- All bank records should be kept for at least seven years, after which they may be shredded.

Financial Report*

- The financial report is to be filled out monthly
- A copy should be sent to the Treasurer and AMS monthly, and Finance and Administrative Team quarterly
- A shortened financial report for the year should be included in each year's Book of Reports submitted to each member of the Executive Committee. This report should include:
 - Each budget line item
 - Total expenditures for each line item for the year
 - Budgeted amount for each line item for the year
 - Total expenditures overall
 - Total overall budget
 - Total Budget Receipts for the General Fund
 - Chart with General Fund Income, General Fund Expenses, YTD Net, Previous Year's Balance Forwarded, Total General Fund on Hand.
 - Reserve/Investment Fund balance
 - Estimated 3 and 6 month operating budget
- Should be available for any DBA church upon request

*The financial report can currently be found on Google Drive titled: DBA Budget Expense Report. This is not a part of the internal financial controls, but listed for information and may change at any time.

Reporting Procedures Continued

Register: A copy of all income and expenditures for the month should be reviewed by the Treasurer and AMS at the end of each month. (QuickBooks>Reports>Banking>Check Detail/Deposit Detail)

Reserve/Investment Fund: Any reserve/investment fund increase or decrease should be reflected on the Financial Report as often as the investment company updates its accounts. Changes and/or deposits may be approved by the Financial Committee, in agreement with the AMS and Treasurer. Withdrawals from the reserve/investment fund must be approved by the Executive Team.

Documentation of Transactions

Hard copy records should be kept of all financial transactions, including but not limited to: receipts, deposit slips, check stubs, online payments, transfers, bills.

Receiving Funds:

- The DBA may receive funds by cash, check, credit card and digitally.
- Incoming funds should be recorded in Quickbooks under their appropriate account or line item
 - Funds received for the regular Operating account should be recorded in 'Donations,' entered as 'Budget Receipts,' and deposited to 'Operating Fund' bank account
 - Invoices should be created for camp registrations, mission trips, or the purchase of items from the DBA. When the payment is received, enter 'Receive Payments'
 - Grants and in/out funds (i.e. Prison Ministry) should be recorded and deposited to the Designated account.
- Deposits should be made at least once per month. Deposit slips should be filed.
- The person/entity who makes a donation to the DBA may request a contribution statement of his/her/it's donation for the fiscal year at any time. Contribution statements are not automatically generated.

Expending Funds:

- Expenditures may be paid by check, ACH, transfer, or be automatically drafted
- If an account is paid by ACH or auto-draft, a receipt will be printed and filed
- Check Request Forms should be filled out for expenditures that do not have a bill which a check stub or payment record can be attached.
- Team Budgets
 - AMS and Team Leader should have a written agreement (including digital communication) for any purchases over \$500 that will be spent out of the Team's budget.
 - Any team member or volunteer other than the AMS or Team Leader spending funds out of a DBA budget account should have prior approval from the AMS or Team Leader.

- Checks
 - Voided checks must be retained. Write 'VOID' on the check and keep it on file.
 - \$500 \$5,000 must seek recommendation from the Treasurer and attached to the check stub (Except for fixed expenses utilities, insurance, van repairs, ect.)
 - Checks under \$5,000 may be signed by AMS, Treasurer, Assistant Treasurer, designated signer, or EA (may be received digitally).
 - Payroll, mileage reimbursements, or any other checks made to DBA staff and signed by DBA staff must seek approval from the Treasurer.
 - \$5,000 and up must be sent to the Finance Team. The Finance Team may choose to seek the Administrative Team's recommendation (may be received digitally).
 Approval must be attached to the check stub and proof of expenditure.

Exception: If a team is on mission and are in need of immediate funds, the leader of the mission team may request verbal approval from the EA, AMS, Treasurer, or Assistant Treasurer for funds needed. As soon as possible, a Mission Trip Cash Request form should be filled out and reviewed by AMS and Treasurer.

- All checks must have a check stub and proof of expenditure. (Proof of expenditure: Bill, Check Request/Reimbursement form, etc.)
- Any checks that are signed should, at a minimum, have the payee line filled out. There are to be no signed checks that are otherwise completely blank.

Credit and Debit Cards

The Executive Team should give written approval (by a majority vote of those who respond) for all credit or credit card accounts. Digital approval is acceptable.

Credit Cards:

- A receipt must be turned in to the EA for all purchases made with a DBA credit card. Attach receipts to the respective credit card bill.
- Note on the receipt what the expense was for, if it is not apparent (i.e. Hospitality for dinner receipt, hotel for conventions, etc)
- Notify EA immediately if the card is lost, stolen, or hacked.

Debit Card:

- The DBA's debit/check card must be kept at the DBA office, in a safe, unless in use.
- The AMS, EA, and Treasurer are the only people who should know the safe key.
- If the debit/check card is needed, the person using the card must sign it out with their name, date, and reason for use. They must sign it back in with the date of return.
- Receipts must be turned into the EA for all purchases made
- Note on the receipt what the expense was for, if it is not apparent
- The expense(s) should be recorded in QuickBooks as soon as possible
- Notify EA immediately if the card is lost, stolen, or hacked.

In the event that a receipt from a credit or debit card purchase is lost or misplaced, a Missing or Lost Receipt form should be completed and attached in the place of the receipt.

Reimbursements

All reimbursements must

- Be paid by check
- Include a completed Reimbursement Request form
- Have proof of expense, such as receipt, attached to Reimbursement Request form
- Have check stub attached to check request form

Reimbursements to the AMS and EA should be minimal as the credit cards should be utilized whenever possible.

Pastor Payroll

The Associational Mission Strategist is usually a pastor. Pastors are taxed differently and are required to submit a Housing Exclusion Form by December 1st each year for the upcoming year.

The Daniell Baptist Association does not automatically withhold taxes from a pastor/AMS salary. Should the pastor/AMS want to have federal taxes withheld, the pastor/AMS should notify payroll in writing (digital is acceptable) and include the amount he would like withheld from each check every year by December 1st.

AMS Discretionary

In the event that a person or entity makes a contribution to the DBA noting that it is to be used as the AMS sees fit, or a memo reads Discretionary, deposit to the Designated bank account. In QuickBooks record as a donation, with AMS Discretionary Receipts as the item. Record the deposit under Designated: AMS Discretionary.

ANNUAL MINISTRY REPORT

This has been a highly productive year for the staff of the Executive Committee despite the deep challenges presented by the COVID-19 pandemic. The commitment of our EC staff to serve the churches of the Southern Baptist Convention and bring us together around the Great Commission is unwavering and shows in the work highlighted in this report.

Vision 2025

Vision 2025 remains our passionate call to Southern Baptists to specific ways we can move forward in cooperatively pursuing the Great Commission. This year's Annual Meeting in Nashville, Tennessee, will give us the opportunity to adopt this vision together.

Vision 2025 is a call for Southern Baptists to reach every person with the Gospel of Jesus Christ in every town, every city, every state, and every nation.

The goals of Vision 2025 are:

Goal #1: Increase full-time, fully-funded missionaries by a net gain of 500, giving us 4,200 full-time, fully funded missionaries through the International Mission Board.

Goal #2: Add 5,000 new SBC congregations to our Southern Baptist family, giving us over 50,000 SBC congregations.

Goal #3: Increase total workers in the field through a new emphasis on "calling out the called" and then preparing those who are called out by the Lord.

Goal #4: Turn around our ongoing decline in reaching, baptizing, and discipling 12to 17-year-olds in the prime of their teenage years.

Goal #5: Increase our annual giving in successive years and establish a new path of growth that will lead us to reach and surpass \$500 million through the Cooperative Program to achieve these Great Commission goals.

A Strong Staff Team

Our entire staff team stands on the shoulders of all the godly men and women who have gone before us. We thank God for them and their contributions serving here. A number of transitions and growth in ministry areas such as the Great Commission Relations & Mobilization team have created the opportunity for God to call a number of talented members to our staff. All of these people have a commitment to the Gospel, a love for Southern Baptists, and a desire to cooperate together to reach the lost. Here are some highlights regarding our strong staff team:

- Almost one-half of our entire staff team has joined us since I came here twenty-one months ago.
 - o Our entire Executive Leadership Team is new.
 - Nine of the ten persons who serve on our Leadership Team are new
- When our Leadership Team of ten persons meets weekly to chart our future forward as a staff and as an Executive Committee, four of the ten persons are non-Anglo. It is comprised of one Hispanic, one Asian American, and two African Americans; one of these men serves as one of our vice presidents. The Lord has provided unique giftedness and diversity on the team of the SBC Executive Committee.
- Each of these ten persons on this Leadership Team are very relational people who love the local church and work diligently to help us move forward.
- All of us are supported by a very strong group of persons who serve with us on our entire staff team who have excellent skills, a diligent work ethic, and a vision to reach the world for Jesus Christ.

Great Commission Relations & Mobilization

Dr. Floyd commissioned the Great Commission Relations and Mobilization team to discover where we were in our SBC congregations by race and ethnicity from 1990-2018. The study revealed 22.3% of our SBC congregations are non-Anglo or ethnic minority congregations. In 1990, 8.4% of our SBC congregations were non-Anglo or ethnic minority congregations. Therefore, our SBC non-Anglo or ethnic minority congregations. Therefore, our SBC non-Anglo or ethnic minority congregations. Therefore, our SBC non-Anglo or ethnic minority congregations have grown by 7,992 congregations since 1990, or by 223%.

Baptist Press shared this information with the greater public in an article here.

The GCRM team interacted with more than 2,000 ethnic ministry leaders through face-toface visits, personal notes, phone calls, and virtual meetings. These connections resulted in increased awareness and connectivity.

The team has also created a leadership pipeline—a database of leaders who have been identified to engage in convention life. The four distinct leadership pipelines (Hispanic, Asian, African American and Young Leaders) include the names of 600 existing and emerging leaders who can be mobilized in the convention at any level. Pipeline participants are encouraged to engage with seminaries, church planters and missionaries and to serve on convention boards and committees when nominated.

The team cultivated existing relationships with the 32 ethnic fellowships who represent more than 11,500 congregations that are ethnically and racially diverse in the SBC. Meetings were held with each of the ethnic fellowships to promote the Cooperative Program, Send Network, the Lottie Moon Christmas Offering, and the Annie Armstrong Easter Offering in ways that were culturally appropriate. The team also consulted with ethnic fellowship on best practices to navigate fulfilling the Great Commission in a COVID-19 culture.

Cooperative Program Promotion and Stewardship Development

Our entire staff team understands their individual role in promoting the Cooperative Program. The Cooperative Program is our financial fuel to reach every person for Jesus Christ in every town, every city, every state, and every nation.

- Our entire Great Commission Relations and Mobilization team focuses on all churches, all generations, all ethnicities and all languages—all for the cause of ultimately mobilizing all persons to the Great Commission.
- Our team has held three state convention Cooperative Program/Stewardship Summits to assist state conventions in the areas of stewardship and promotion.
- Our team has developed a Cooperative Program Digital Kit for churches.
- We are offering our churches multiple, new Cooperative Program videos—a
 wonderful collection that tells the story of what God is doing and also helps churches
 promote the Cooperative Program. We are also thankful for the International Mission
 Board and the North American Mission Board, who each are providing new
 Cooperative Program videos to help us promote missions here in North America and
 around the world.
- Stewardship development and Cooperative Program promotion go together. This is why we have developed a special resource that was released in the fall of 2020.
- Ten Percent: A Call to Biblical Stewardship
 - This free resource for churches consists of six stewardship sermons and six Bible Study lessons which a church can use to deepen their commitment to biblical stewardship.
 - Since the release of this free resource, more than 18,000 printed copies have been distributed and more than 1,100 digital resource kits have been downloaded.
 - o This stewardship resource is also available in Spanish.

Convention Communications

In 2020, our team worked with Useful Group to completely rebrand the SBC logo suite. This work included new logos and branding for the Cooperative Program, Baptist Press, SBC Life, and the main SBC brand.

The team also worked with Mere Agency to overhaul and update all of our SBC web properties including the SBC main site, Baptist Press, SBC Churches, SBC Jobs, Baptist Press, SBC Annual Meeting, and BFM2000 websites.

Baptist Press, the official news service for Southern Baptists, updated its workflow and strategy for news coverage to a modern digital approach. This shift, along with editorial refinement, resulted in a 26% increase in website traffic in 2020 with more than 5.8 million pageviews. BP en Español also received a strategic shift to better serve Hispanic Southern Baptists. For the first time in its history, BPEE is led by an editor who is fluent in Spanish and Hispanic culture.

The SBC Life Journal, a printed piece mailed to more than 55,000 churches and individual Southern Baptists, also received a makeover. Its new magazine-style format updated the look, feel, and focus of the publication.

The team also continued to develop more online offerings to inform and communicate with Southern Baptists. The SBC Morning Briefing, Advancing the Vision, and the BP Afternoon Digest land in more than 150,000 inboxes every week.

Increasing awareness through digital video has also been an emphasis of the team. The Road to Nashville, a weekly video series to promote SBC Annual Meeting attendance and engagement, was launched in early 2021 in anticipation of this year's Annual Meeting in Nashville. Also, Baptist Press partners with GuideStone to produce the Monthly Market Update—a monthly look at the economy and stock markets and how they impact Southern Baptists and cooperating churches.

Finally, the team rebranded and relaunched CP Stories (formerly 52 Weeks) to provide churches a weekly resource to promote missions and ministries funded by the Cooperative Program.

Preparation for the 2021 SBC Annual Meeting

Preparations are well underway for the 2021 Southern Baptist Convention that will be hosted in Nashville, Tennessee, on June 15-16, 2021. The theme—We are Great Commission Baptists—provides a strong focus for our return together after the COVID-19 pandemic. This theme sets the stage for the adoption of Vision 2025 as the call to Southern Baptists to cooperate together in unprecedented ways to in advancing the Gospel.

The Gaylord Opryland Resort and Convention Center is a wonderful setting for us to come together. This beautiful hotel provides room for all of the meetings and events surrounding the Annual Meeting and allows Southern Baptists to be together throughout this event to pray, worship, fellowship, engage, and commit ourselves to our cooperative mission

2021 SBC Ministry Report President's Letter

I am happy to share with you about what God is doing as we partner together to help churches reach North America for Christ.

At NAMB, it's all about the Gospel. The reason we do everything we do is to help Southern Baptists make disciples in North America and beyond.

You will find many details inside this ministry report, but I want to share a few of the highlights with you now.

I don't have to tell you what a challenging year 2020 was. In many ways, those same issues have followed us into 2021. But I am happy to report that at NAMB, the mission moves forward. We have not pulled a single missionary from the field due to budget. We have not cut evangelism funds, and no missionary has had his or her funding cut. We will continue to do whatever it takes to protect these essential ministries as we get through this crisis together.

I am so proud of our church planting missionaries who have been serving their communities courageously during this time. So many have been delivering food, serving healthcare workers and providing much-needed encouragement and hope.

Our Send Relief missionaries and ministry centers have been doing the same. Hundreds of thousands of meals have been prepared and distributed, thousands of pieces of personal protective equipment have been delivered to frontline healthcare workers and vulnerable populations are being served every day.

Throughout the challenges of this past year, we have continued to provide pastors with the tools they need to proclaim the gospel and equip their congregations for evangelism. Our Who's Your One Tour with Johnny Hunt continued in both in-person and virtual formats. We are expanding our student evangelism resources, and we added Paul Worcester to our evangelism team as National Director of Collegiate Evangelism to help Southern Baptists reach this critical next generation of students.

We announced a new partnership last year with IMB which means Send Relief's ministry now reaches all the way around the world. Whether through giving or hands-on service, your church can meet needs right in your hometown, on the other side of the globe and everywhere in between.

And we are ramping up our leadership resources for pastors with Next Step Leader, led by Will Mancini. Will is an established leader in the realm of Christian ministry. At this critical time when pastors need new tools in their leadership toolbox, Will has joined with us to bring free training to every pastor in our Southern Baptist family.

Of course, many of our pastors are experiencing great discouragement as they deal with the pressures the pandemic and related challenges. Pastor care is more important now than ever as we seek to encourage and build up these men who lead our churches. This is why our Timothy+Branabas events continue to serve pastors across North America. In the year ahead, we are looking to expand and bring this conference to additional places so we can bring healing and encouragement to many more pastors in need.

Thank you for how you support our nearly 6,000 missionaries and chaplains. The Annie Armstrong Easter Offering supports your missionaries in North America, and before this past year, we saw record Annie offering totals for three years in a row. What a remarkable trend! Last year the pandemic hit in the spring. Just as most churches would have been receiving the Annie offering, they were closing their doors and going into lockdown. The offering total dropped to \$49.3 million, but there is still great reason to celebrate. God's faithfulness and the generosity of Southern Baptists is remarkable, and we are deeply grateful.

At NAMB, pastors are our number one customer. We are here to serve you through Send Network by helping you plant churches everywhere for everyone. We help you share Christ while meeting needs through Send Relief. And we help you send hope, by providing resources to proclaim the Gospel and equip your church for evangelism.

It really is all about the Gospel.

Thank you, Southern Baptists, for allowing us to serve and partner with you. We are grateful for what every church is doing to reach its community and join arms in the effort to reach North America and the world for Christ.

God bless you, and may God bless the effort of Southern Baptists as we take the Good News of Jesus Christ to the world.

Introduction

On behalf of the International Mission Board, I'm thrilled to report to you that for 175 years, the Southern Baptist Convention has not failed to have a witness among the nations! While 2020 brought us all the challenges of a global pandemic, the year also marked the 175th anniversary of Southern Baptist mission work around the world. We give gratitude to God for all that Southern Baptists are doing to reach the world for Christ. We thank Him that He has maintained our collective missions efforts despite COVID-19 and other challenges that affect international work.

Each generation of Southern Baptists has answered the call to cooperative missions and given their prayers and support to their IMB missionaries. Today, more than 3,550 missionaries continue to journey into difficult and spiritually impoverished places on Earth to sow seeds of love and truth, and to enable the lost to know the saving grace of Jesus.

Thank you for providing for these missionaries through your Cooperative Program and Lottie Moon Christmas Offering® gifts. Your faithful support through both CP and the LMCO are the financial lifeline for Southern Baptist international missions. Southern Baptists gave \$159.5 million in the 2019-20 LMCO campaign — the second-highest Lottie Moon offering ever received. IMB also received \$97.2 million from the Cooperative Program for 2019-20.

A concerted effort to enlist prayer support for "175 Days of Prayer" resulted in at least 12,000 supporters interceding on behalf of work around the world from May through December last year. Southern Baptists around the globe shared prayer requests through social media and email, lifting up those who have never heard the gospel, and asking the Lord of the Harvest to send forth more workers.

As a result of your financial gifts and your unwavering prayer support — because you gave, because you prayed, because you sent your family and friends — it's my honor to report that:

- 535,325 people heard a gospel witness last year as IMB missionaries and their close indigenous
 partners continue to share the gospel boldly.
- 89,325 people became believers, committing to follow Jesus Christ in their lives, with 47,929 following through with believer's baptism.
- 12,368 new churches were planted as your missionaries continue to disciple new believers, and then do the all-consuming work of pulling those new believers together in the birth of a new church. Missionaries also reported 174,393 people who are ongoing Bible study participants.

 And an incredible 90,532 people received theological training, which includes pastoral training, church-planting training, advanced training, and more.

While we rejoice in the advancement we have seen in the gospel, we are sobered by the reality that 154,937 people die every day without Christ. That's one precious person every 2 seconds. We also face the reality that nearly 1.5 million people join the global population weekly (that's more than 215,000 every *day*); and yet estimates indicate that evangelical Christians share the gospel about 275,000 times per *week*. We cannot — we must not — be passive in our efforts toward gospel advance. We must be strong, focused, and committed.

As the organization representing Southern Baptists and our calling before God to share Christ among the nations, the IMB has felt a great responsibility during this pandemic to care for the resources entrusted to us. To Southern Baptists, again, I want to say thank you for allowing us to serve you in carrying out the Great Commission in partnership with you and your church. Much remains to be accomplished — but together, under the power of Christ, we can continue to welcome the multitudes before His throne, as we see in the Rev. 7:9 vision.

The key is cooperation: working together.

Every church, regardless of its size or resources, has a part to play in reaching every nation with the gospel. We continue to trust God and to call upon every Southern Baptist to be generous in your praying, sending, going, and your increased giving through the Cooperative Program and the Lottie Moon Christmas Offering. There is no greater work than the one we share in proclaiming Christ to people who have never heard of His great name! Thank you for doing your part.

Dear Member of the Executive Committee:

As is always the case, I am privileged to submit a report to you from your Ethics & Religious Liberty Commission about the work of our ministry over the last year.

It is clear that these are strange and tumultuous times. A time of revelation, in the truest sense of the word, about our culture and our churches. The events of 2020 have shown us much about this moment that we inhabit: a lack of trust in institutions throughout the public square; a divided and polarized political landscape, with hostility more common than seeking the common good; and the very real frailty of our lives in the midst of a pandemic that has taken the lives of thousands of Americans. If anything has been revealed to those watching, and has been reaffirmed for the church, it is just how desperately the gospel is needed for a world in chaos and groaning for redemption. In the midst of this challenge, the ERLC has sought to provide a consistent voice applying the moral demands of the gospel to the issues confronting the church.

The pandemic, predicted by no one when we were planning for the upcoming year, has brought forth a number of difficult challenges. From a death toll that continues to rise to the economic instability caused by the loss of jobs, people have understandably lost a sense of security and safety. Even the measures meant to safeguard the most vulnerable—social distancing, shutdowns, cancellation of weddings and funerals—have caused their own forms of sadness, frustration, and isolation.

However, even in these trying times, there are moments of grace. Churches and Christians have adapted to this moment and done the seemingly impossible. Thousands, almost overnight, transitioned to digital platforms and asked "How can we serve our neighbors in this moment?" Your ERLC has sought to equip the church by creating a platform on our website that hosts Covid-19 resources and articles. It features videos from pastors and ministry leaders across the country discussing how they have led their congregations in innovative and inspiring ways.

As vaccines to end this terrible plague have been developed, your ERLC hosted Dr. Francis Collins, the head of the National Institutes of Health and a faithful Christian, to discuss the truth about vaccines and equip pastors with the information they need for their congregations.

We have spent the past year working with Congress to protect the eligibility of local churches to secure loans through the CARES Act and the SBA Paycheck Protection Program, all while ensuring proper

901 Commerce St, Ste. 550 615-244-2495 Nashville, TN 37203 erlc.com protections for religious freedom were put in place. Further, we have worked with governors, Members of Congress, and local leaders to ensure that religious liberty is protected alongside public health.

Our work in other realms has not ended, even as it has taken on new forms in the midst of the pandemic. We have continued the work to advance religious freedom in a number of avenues, most notably an amicus brief cited in the Supreme Court majority opinion ruling that churches have the right to hire staff consistent with their convictions. Further, we have joined in cases against an abortion industry that has attempted to use the pandemic as a pretext for their horrific agenda. Moreover, to advance the cause of life, this past fall we were able to announce an incredible victory for our Psalm 139 Project through a generous donation that allows us to place 10 ultrasound machines in pregnancy resource centers across the country—a record for our initiative.

Our advocacy for religious liberty extended to the international front as we advocated on behalf of persecuted Christians and Muslim Uyghurs in China, a minority religious group oppressed by the Chinese government for their beliefs.

Finally, a fractured public square confronted us at the conclusion of 2020, something no one can dispute. Our team, in an effort to resource pastors and local churches, created the Church and Civility Church Toolkit to provide sermon outlines and guided discussions centered on the topics causing division in churches and around the dinner table. However, while we believe this resource was useful, more must be done. As part of that, our team continued our work speaking in churches on these issues as the year came to a close, and we will continue in the days ahead to advocate for convictional kindness to be displayed in the public square.

The past year has been a year of chaos and a year of revelation. The ERLC has endeavored to represent Southern Baptists in the public square with the truth of the gospel courageously, and the kindness that is our weapon of war against the forces of hatred and division. But this year also served as a reminder of God's abundant kindness and the great work that churches are doing daily. As we look to the next year, I am encouraged to be joining with thousands of Southern Baptist congregations to carry the message of the gospel to a world sorely in need of its hope, its stability, and its grace.

Dear Southern Baptist Family,

Greetings on behalf of the entire team at Lifeway Christian Resources. I'm honored to provide this report on the work of Lifeway. But first let me say thank you for your faithfulness to Jesus Christ's call to go and make disciples of all people. We're grateful to be partners with you in this global mission.

As I look back on 2020, I am humbled and awed by the many ways God has shown His tremendous blessing and provision during a difficult year. The past year brought strange and challenging days for the local church and its leaders, as well as for Lifeway. We have been tackling these challenges head on as we adapt and find new ways to serve churches during the COVID-19 crisis and beyond. You'll find many details within our ministry report, but allow me to share some highlights.

Little did we know at the beginning of 2020 how the coronavirus would impact the ministry of the local church. In March, when COVID-19 began to impact the ability for churches to gather, Lifeway very quickly felt the effects of nationwide shelter-at-home orders. It seemed like overnight we went from serving the church gathered to serving the church scattered.

I'm proud of how quickly the teams at Lifeway came together to provide free digital resources to churches, families, and individuals so discipleship could continue. We saw numerous churches shift to online services while Sunday School classes and small groups continued to meet using Zoom and Facebook. And Lifeway was there to help.

Lifeway Leadership released Curriculum Powered by Ministry Grid, which gave churches free digital access to Lifeway Bible studies: The Gospel Project, Bible Studies for Life, Explore the Bible, and YOU. This free access allowed more than 7,200 churches and 72,000 individuals to continue using Lifeway Bible studies during the spring and summer months when many churches did not meet in person. Our Sunday School and small group specialists regularly led online webinars and consulted daily with church leaders around the country to help them navigate leading groups during the COVID-19 pandemic.

As spring turned to summer, we began to hear from children's ministers looking for ways to host Vacation Bible School. Our Lifeway Kids team developed strategies to help churches adapt their traditional VBS. Evangelism and Christian education continued even during a difficult and dangerous pandemic. Based on early reports, churches saw more than 900 participants make professions of faith through VBS in 2020.

Throughout the summer and fall, our Lifeway events team worked hard to provide a number of online experiences in place of in-person gatherings. Lifeway's ETCH Conference for children and student leaders moved from being a physical event in 2020 to a virtual one, reaching more than 900 leaders who serve in their church's ministries to kids and students. More than 6,000 people tuned in for the 2020 Black Church Leadership and Family Conference held virtually for the first time.

Throughout the year, Lifeway reached more than 40,000 women with a number of digital events hosted by hundreds of churches and streamed by over 27,000 individuals. We saw more than 100,000 women join one of the Lifeway Women's online Bible studies in 2020.

It was exciting to hear how thousands of men and women gathered together virtually throughout the year for Bible study, worship, and ministry training.

In January of this year, we unveiled a new logo and began a significant update and refresh of our website at lifeway.com. The new logo and visual elements reflect a new season of ministry for Lifeway. And our brand promise is true to the legacy of Lifeway and affirms our commitment to serve churches and provide fuel to their ministries.

We know the COVID-19 crisis created a unique challenge for churches as they found new ways to gather and minister to their communities. The local church has experienced a massive transformation as a result of the pandemic that will alter the way it functions in the future. We've been working on solutions for supporting local churches as they begin to rebound and regather in person. As churches transform to meet the needs of their communities, we know Lifeway must adapt as well.

Through this difficult season, Lifeway has continued to provide trustworthy biblical resources for spiritual growth to churches and individuals. Whether through ongoing Bible study curriculum, creating discipleship experiences for all ages, or equipping church leaders, our team continues to work on opportunities to better serve churches.

Yes, these are challenging times, but we must never forget that we are in God's hands. I am confident the Lord will use this season for His glory and will push His church into the future in a fresh way.




